#### **Annual Election**

#### Street Light Outage

If you notice a street light out in the common area, please contact the management company to report the matter. They will need a location of the light pole and if available, the pole identification number. That number is located on the street side of the pole and is imprinted on a piece of metal that is approximately 3/4" wide by 8" in length. The information will be reported to the Edison Company.

## **Parking Information**

As a reminder, residents are not permitted to park their vehicles on the streets overnight. Any guest vehicle that is parked on the street must display a "Visitor Parking Pass". There have been some problems with guards improperly issuing visitor passes for extended periods of time. The guards have been reminded of our rules and the problem should be corrected. Just to clarify, visitor passes are for our visitors. The passes are not to be issued for a period of time longer than 7 days. Any time longer than that will require association approval.

## **Access Gate Remotes**

If you are in need of an access gate remote, you can purchase one from the association. To purchase the remote, please call our management office and one can be mailed to you. The cost for the remotes are \$45.00 each.



## Pool Area Upgrades

The Board of Directors has approved work in the common area pool area that will include the repair and replacement of the pool deck, replastering and new tile in the pool and spa and the renovation of the pool area restrooms. Efforts will also be made towards the repair and painting of the gazebo. This work should start within the next few weeks and weather permitted will be done by mid to late spring.
