
Street Light Outage

If you notice a street light out in the common area, please contact the management company to report the matter. They will need a location of the light pole and if available, the pole identification number. That number is located on the street side of the pole and is imprinted on a piece of metal that is approximately 3/4" wide by 8" in length. The information will be reported to the Edison Company.

Iron Fence Painting

Please take a few moments and inspect the fencing around your home. Most residents have some white iron fencing around their homes. This fencing needs to be painted every couple of years to keep it from rusting and failing. Many of our owners need to repaint their fencing. Inspections will be conducted to locate and notify owners accordingly.

Noise Issues and Concerns

Mosquito Alert

We know that with the heavy rains we have had this past winter, the mosquito population in our area will be heavily increased. A larger population of mosquitoes translates into a greater chance for viruses such as the West Nile Virus to be transmitted to animals and people. We need your help to address this concern. Please inspect your yard and eliminate any areas of stand-This includes planter dishes, ing water. bowls, etc.. If you have a pond or fountain, you need to treat the water or add mosquito fish to eliminate the mosquito larvae.
