Orange County Sheriffs Reminders

The Orange County Sheriffs Department has put a list of Crime Advisory Scam reminders for the community to follow and each month we will list out a few of them, but for the full document please go to the Associations website for the entire listing.

Text Phishing Scheme

The suspects in this scam are targeting disability applicants and beneficiaries by sending them text messages on their cell-phone asking them to call. The text messages have read "Disability Alert: Please call 253-XXX-XXXX regarding your recent disability benefits application." The numbers to call have varied but the wording has been about the same. When the number is called a person claiming to be a Government official asks for personal identifying information. We have received reports of identity theft where victims have fallen for this scam.

WHAT YOU CAN DO TO COMBAT THIS SCAM

- Never blindly respond to a text message by calling the number given. Do some research and find the actual number for the entity you are trying to call.
- Call the agency the person is from directly to verify their identity. Social Security has a toll free number to call: 1(800) 772-1213. If this is a scam after being verified, please call the Social Security Fraud hotline at 1(800) 269-0271 and via email at www.oig.ssa.gov/report
- If you are or suspect a you are being scammed, please call the Sheriffs Department Non Emergency Line to file a report. (714) 647-7000 or (949) 770-6011.

Community Reminders:

- Driving Reminders: Golf carts are for golf course lawns. Please help the Association use its resources to maintain and improve the Association landscape. Kindly keep golf carts, motorized bikes, and scooters off of the Association maintained landscaping and trails. Thank you!
- Parking Reminders: As a resident, if you obtain a new vehicle, please note that a transponder/decal will be necessary to access the gate. New transponders can be obtained by filling out the new transponder form and making a payment of \$25.00. Once the form has been completed, please kindly email the completed document to: Bri-an.Salas@SeabreezeMgmt.com where we will help coordinate with the guard house to provide the item.
- Pool and Spa Reminders: With the Spring season fast arriving, we would like to remind everyone of a few rules for the pool and spa area. To start, the gates are never to be propped open, no pets are allowed in the pool and spa area, and guests must be accompanied by the resident living in Rancho Cielo. We also ask that that when leaving the area all trash must be disposed of and there is no glass permitted in the vicinity. Lastly, the pool and spa hours are from Friday–Saturday 6:00AM-12:00AM and Sunday-Thursday 6:00AM-11:00PM.

IMPORTANT: SAFETY REMINDER

While Rancho Cielo's community streets are not a suitable play area for children, more children are at home now, and they are playing outside. <u>Please</u> take care and travel with caution through the community streets. Vehicles are not to exceed 25 MPH on community streets. If you see a vehicular safety concern, please contact your local law enforcement at 949-770-6011. Describe specifically what you observed, including who or what you saw; when you saw it; where it occurred; and why it's dangerous or suspicious. If there is an emergency, call 9-1-1. Thank you for helping to keep Rancho Cielo safe!

More Community Reminders:

- Clean Up After Your Pet. Besides being unsightly and creating a noxious odor nuisance, animal waste can be hazardous to the health of residents and other pets. While walking your dog in the community, remember that it must be leashed on a leash 6-feet or less, and under the care of a competent adult. Be sure to immediately clean up after your pet. Please take along a baggie with you to pick up waste and dispose of it properly.
- ACH: Did you know that you can have your HOA Assessments pulled out directly from your checking account, like you would with your gym and many of your energy expenses? Please email Customer Care at customercare@seabreezemgmt.com to request for an ACH Form to be sent to your home. A voided check must be stapled to the enrollment form, and must be received no later than the 25th of the month so that your account will be set up for ACH on the 10th of the following month. A letter is sent confirming your set up draft month. Please continue to make payments by check until you have received your confirmation letter. All enrollment forms received after the 25th will be delayed an additional month. ACH is processed on or around the 10th based on your association's billing cycle. Your account must be in current status to be eligible.
